

ORDINANCE NO. 7804

AN ORDINANCE PROVIDING FOR AN ADDITIONAL ALLOWANCE OF FIVE HUNDRED PESOS (P500.00) TO JUDGES OF THE METROPOLITAN TRIAL COURT OF MANILA ACTUALLY HOLDING NIGHT COURT SESSIONS AND ONE HUNDRED PESOS (P100.00) A MONTH TO EACH OF ITS STAFF PERSONNEL, AND APPROPRIATING THE NECESSARY AMOUNT FOR ITS OPERATIONAL FUNCTIONS.

Be it ordained by the City Council of Manila, THAT:

**SECTION 1.** Judges of the Metropolitan Trial Court of the City of Manila who are assigned to hold Night Court Sessions are hereby given the authority to collect an additional allowance of FIVE HUNDRED PESOS (P500.00) a month, and ONE HUNDRED PESOS (P100.00) for each staff personnel not exceeding eight, and who actually, render night duties thereat.


**SEC. 2.** The amount of FOUR HUNDRED SIXTY-EIGHT THOUSAND PESOS (P468,000.00) or so much thereof, as may be necessary, is hereby appropriated out of any fund or funds existing in the City Treasury not otherwise appropriated, to be made available for the aforesaid allowances; PROVIDED, that the said amount shall be incorporated in the Annual Executive Budget of the City.


**SEC. 3.** This Ordinance shall retroact to January 1993.
