

ORDINANCE NO. 7812

ORDINANCE PRESCRIBING RATES FOR PARKING, IMPOSING TOWAGE, IMPOUNDING AND STORAGE FEES FOR STALLED MOTOR VEHICLES AND FINE FOR ILLEGAL PARKING AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. There shall be charged, assessed and collected against owners, operators and drivers of motor vehicles using and utilizing city pay parking areas, parking fees, at rates as provided hereunder, to wit:

| 1. light vehicle (car, jeep, tricycle, pedicab and motorcycle) | P 6.00 for the first three hours
P 2.00 for every hour thereafter |
| 2. medium vehicle (van, delivery truck except 10-wheeler truck) | P 8.00 for the first three hours
P 3.00 for every hour thereafter |
| 3. heavy vehicles (bus, 10-wheeler truck, heavy equipment) | P10.00 for every parking lot occupied
P 4.00 for every hour thereafter |

SEC. 2. Any provision/s of existing ordinances notwithstanding, all motor vehicles, illegally parked or stalled on any street, road or thoroughfare within the City not otherwise designated as parking areas shall be towed to designated impounding areas to be released only to the owners, operators, drivers or duly authorized claimants upon payment of the corresponding towage and impounding fees in accordance with the following schedule:

	<u>Towage Fee</u>	<u>Impounding Fee</u>
1. light vehicle (car, jeep, tricycle, pedicab, motorcycle)	P 500.00	P 50.00/day
2. medium vehicle (van, delivery trucks except 10-wheeler)	P 750.00	P 75.00/day
3. heavy vehicle (bus, 10-wheeler truck, heavy equipment)	P1,000.00	P 100.00/day

In addition thereto, said owners, operators and drivers shall pay the fine as provided in Section 3 hereof.

SEC. 3. There shall likewise be imposed upon the said owners, operators and drivers of illegally parked or installed vehicle, a fine of TWO HUNDRED PESOS (P200.00).


SEC. 4. The Office of the Mayor shall henceforth issue the necessary rules and regulations to implement the objective, purpose and intent of this ordinance.


SEC. 5. This Ordinance shall take effect upon approval.
