

ORDINANCE NO. 7813

AN ORDINANCE AUTHORIZING HIS HONOR, THE MAYOR, TO INITIATE THE ACQUISITION BY NEGOTIATION, EXPROPRIATION, PURCHASE, OR ANY OTHER LEGAL MEANS, CERTAIN PARCELS OF LAND (TCT NOS. 169193, 169198, 169190, 169200, 169202 AND 169192) ALL SITUATED IN THE 2ND DISTRICT OF MANILA FOR THE BENEFIT OF THE TENANTS/RENTERS WHO ARE BONA FIDE MEMBERS OF ANTONIO RIVERA HOMEOWNERS ASSOCIATION, INC. AND ARE RESIDENTS OF SAID AREA, AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. His Honor, the Mayor, is hereby authorized to cause the acquisition by negotiation, expropriation, purchase, or any other legal means certain parcels of land registered under Transfer Certificates of Title Nos. 169193, 169198, 169190, 169200, 169202 and 169192 of the Registry of Deeds, for the City of Manila, situated in the 2nd District of Manila;

SEC. 2. The subject parcels of land sought to be acquired shall be for the benefit of all actual, bona fide, qualified residents/tenants especially those who have worked with the Homeowners Association in the said area;

SEC. 3. The amount of P7,374,604.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury for the acquisition of the parcels of land mentioned in Section 1 hereof;


SEC. 4. The Housing and Urban Development Board, with the assistance of the Urban Settlements Office, shall oversee the implementation of this effort and to provide the tenants their designated lots.


SEC. 5. This Ordinance shall take effect upon approval.


