

ORDINANCE NO. 7814

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ACQUIRE, BY NEGOTIATION OR EXPROPRIATION, THE SIX-HECTARE MANOTOC SUBDIVISION IN DULONG GAGALANGIN, TONDO, MANILA, UNDER TRANSFER CERTIFICATES OF TITLE NOS. 128803, 128804, 128252, 128253, 128254, 128255 AND 128256 FOR DISTRIBUTION AND SALE TO BONA FIDE TENANTS THEREAT.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. In line with the land-for-the-landless program of the City, the City Mayor is hereby authorized to acquire, by negotiation or expropriation, the six-hectare Manotoc Subdivision in Dulong Gagalangin, Tondo, Manila, under Transfer Certificates of Title Nos. 128803, 128804, 128252, 128253, 128254, 128255 and 128256 for distribution and sale to bona fide tenants thereat.

SEC. 2. The sum of THIRTY FIVE MILLION PESOS (P35,000,00.00), or so much thereof as may be necessary shall be appropriated from funds not otherwise appropriated for the purpose. In order to support this funding requirement, the City Mayor is authorized to negotiate with the National Housing Authority and other housing agencies for funding assistance.


SEC. 3. The distribution, award and sale of the said property shall be in accordance with the established rules and regulations of the City's housing and land program.


SEC. 4. This Ordinance shall take effect upon approval.




