ORDINANCE NO. 78.13

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO CAUSE THE INSTALLATION OF CONCRETE SLAB-COVERING ON TOP OF A PORTION OF ESTERO DEL CARMEN IN QUIAPO, AND THE CONSTRUCTION THEREON OF A PARK-PROMENADE AND OTHER STRUCTURES FOR GENERAL PUBLIC USE, AND APPROPRIATING THE NECESSARY FUNDS THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The City Mayor is hereby authorized to cause the installation of concrete slab-covering on top of a portion of Estero del Carmen in Quiapo, and the construction of a Park-Promenade and other structures for general public use thereon, subject to the necessary clearance from the Department of Public Works and Highways.

There is hereby appropriated from any available SEC. 2. funds of the City government the sum of TEN MILLION PESOS (P10,000,000.00) for the installation of concrete slab-covering on top of a portion of Estero del Carmen in Quiapo, and the construction thereon of a Park-Promenade and other structures for general public use.

This Ordinance shall take effect immediately. SEC. 3.
