## ORDINANCE NO. <u>782</u>7

AN ORDINANCE AUTHORIZING HIS HONOR, MAYOR ALPREDO S. LIM, TO NEGOTIATE BY ANY OTHER LEGAL MEANS, FOR THE PURCHASE OR ACQUISITION, OF A PARCEL OF LAND OWNED BY THE PHILIPPINE NATIONAL RAILWAYS (PNR), CONSISTING OF 5,458.08 SQUARE METERS, SITUATED ALONG THE CORDILLERA JUNCTION TO SAN JUAN RIVER (GUADALUPE LINE) STA. MESA, MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. His Honor, Mayor Alfredo S. Lim, is hereby authorized by any other legal to negotiate for the purchase or acquisition, means, of a parcel of an inoperative tract of land belonging to the PHilippine National Railways (PNR), consisting of 5,458.08 square meters, situated along the Cordillera Junction to San Juan River (Guadalupe Line), Sta. Mesa, Manila.

- SEC. 2. The aforementioned parcel of land so acquired shall be resold to qualified and bona fide tenants/occupants of the same at cost and on installment basis not exceeding twenty-five (25) years.
- SEC. 3. The amount of P7.5 Million, or so much thereof as may be necessary, is hereby appropriated out of the general fund or funds of the City of Manila, not otherwise appropriated for other purposes, for the purchase of the same.
- The Housing and Urban Development Board, with the assistance of the Urban Settlements Office, shall oversee the selection of beneficiaries and awarding of the lots to address the objective contemplated in this Ordinance.
  - SEC. 5. This Ordinance shall take effect upon its approval.
