

ORDINANCE NO. 7828

AN ORDINANCE ESTABLISHING THE OFFICE OF SENIOR CITIZENS AFFAIRS (OSCA) IN THE CITY OF MANILA AS PROVIDED FOR IN REPUBLIC ACT NO. 7432, OTHERWISE KNOWN AS THE SENIOR CITIZENS ACT.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. This Ordinance shall be known as the "Senior Citizens Affairs" Ordinance.

SEC. 2. Declaration of Policy. It is hereby declared the policy of the City of Manila to give utmost priority to the needs of the senior citizens of the City, motivate and encourage them to contribute to nation-building and insure that essential goods, health and other social services shall be available to them at affordable cost and reaffirm the value of the Filipino tradition of caring for the senior citizens.

SEC. 3. In accordance with the above-declared policy, and pursuant to Sec. 7 of R.A. 7432, otherwise known as the Senior Citizens Act, there is hereby created in the Office of the Mayor, the Office of Senior Citizens Affairs (OSCA), to be headed by a duly elected councilor.

SEC. 4. The OSCA shall perform the function of implementing the provisions of R.A. 7432 and its Implementing Rules and Regulations and such other functions as may be provided by law or ordinance.

SEC. 5. In order to carry out its mandated functions, the following positions are hereby created to constitute the personnel complement of the office:

One	(1)	Administrative Officer III
One	(1)	Administrative Officer II
Six	(6)	Social Welfare Officer II
Three	(3)	Public Relations Assistant
Four	(4)	Clerk II
Two	(2)	Driver II
Three	(3)	Utility Worker I

PROVIDED, that the filling up of these positions shall be made in accordance with the civil service law, rules and regulations.

SEC. 6. The amount needed to cover the honorarium, salaries, wages, allowances, benefits and mandatory contributions pertaining to the positions created above, including the maintenance and operating expenses and capital outlay, shall be appropriated in the supplemental budget and thereafter incorporated in the annual budget of the City.

SEC. 7. Separability Clause. Any provisions of this ordinance not otherwise declared invalid shall remain in full force and effect.


SEC. 8. This Ordinance shall take effect upon its approval.


