

ORDINANCE NO. 7834

AN ORDINANCE GRANTING FOUR-YEAR COLLEGE SCHOLARSHIP TO STUDENTS WHO GRADUATE AS VALEDICTORIANS FROM PUBLIC HIGH SCHOOLS IN MANILA.

Be it ordained by the City Council of Manila, **THAT:**

SECTION 1. All students who are bona fide residents of the City of Manila, as certified to by the Barangay Chairman, and who graduate as valedictorians from public high schools, shall be entitled to a four-year scholarship in any private college in the City of Manila.

SEC. 2. Such students are entitled to pursue any four-year course in college with free tuition fees, textbooks and other school fees.

SEC. 3. The tuition fees and other school fees, including the expenses for textbooks, shall be defrayed by the government of the City of Manila.

SEC. 4. Such scholarship shall exist, as long as the students maintain a general average of 90% at the end of every school year and shall cease to exist if they obtain a general average lower than 90%.

SEC. 5. Each student shall be entitled to TWENTY THOUSAND PESOS (P20,000.00) a year, to cover the above-mentioned expenses.

SEC. 6. Payment of the actual expenses for the school year shall be made by the City Treasurer in the form of Check or Treasury Warrant, payable to the school or college where the student is enrolled. Such actual expenses shall be submitted by the student to the City Treasurer.

SEC. 7. Each student who shall be awarded this four-year college scholarship must render professional service to the City of Manila for at least 2 years after graduation.

SEC. 8. The amount of SIX HUNDRED TWENTY THOUSAND PESOS (P620,000.00) is hereby appropriated out of the City Treasury, to defray the expenses for the first year and an equivalent amount shall be incorporated in the City Budget, every year for the succeeding years, for purposes of this Ordinance, until the total amount of TWO MILLION FOUR HUNDRED EIGHTY THOUSAND PESOS (P2,480,000.00) shall have been appropriated for four (4) years.

SEC. 9. This Ordinance shall take effect upon its approval.
