

ORDINANCE NO. 7839

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ACQUIRE EITHER BY PURCHASE, NEGOTIATION, OR EXPROPRIATION, A 2,700-SQUARE-METER PRIVATE PROPERTY, COVERED BY TCT NOS. 101893, 101888, 101889, 98720 AND 98721, FOR AWARDING TO ACTUAL AND BONA FIDE TENANTS AT THE LOWEST POSSIBLE PRICE IN BARANGAY 206, ZONE 19, IN TONDO II, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM, APPROPRIATING THE NECESSARY FUNDS NEEDED THEREFOR AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The City Mayor is hereby authorized to acquire, either by purchase, negotiation, or expropriation, a 2,700-square-meter parcel of land, owned by Mrs. Petronilla Janda, for awarding to actual and bona fide residents thereat at the lowest possible price, under the Land-for-the-Landless Program.

SEC. 2. The amount of FIVE MILLION PESOS (P5,000,000.00), or so much thereof as may be necessary, is hereby appropriated from any available funds in the City Treasury, for the purpose of acquiring the above property.


SEC. 3. The above undertaking shall be supervised by the City Housing and Urban Development Board, in coordination with the Urban Settlements Office, with the direct and active participation of the tenants/members, the councilors representing the district and the barangay officials involved in planning and implementation.


SEC. 4. This Ordinance shall take effect immediately.
