

ORDINANCE NO. 7854

AN ORDINANCE RENAMING INDIANA STREET IN THE 5TH DISTRICT OF MANILA, PILAR HIDALGO LIM STREET.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Indiana Street, from Pedro Gil Street to Remedios Street, in the 5th District of Manila, is hereby renamed **PILAR HIDALGO LIM Street.**

SEC. 2. The City Engineer is hereby directed to replace or cause the replacement of the present street signs installed at strategic places thereat.


SEC. 3. Copies of this Ordinance shall be furnished the Office of the President, the Office of Congressman Amado S. Bagatsing of the 5th District of Manila, and the Philippine Postal Corporation.


SEC. 4. This Ordinance shall take effect upon its approval.
