

ORDINANCE NO. 7857

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO MRS. HEIDI L. SAYSON, WIDOW OF THE LATE SPO3 RICARDO L. SAYSON, JR., MEMBER OF THE WESTERN POLICE DISTRICT COMMAND (WPDC), IN RECOGNITION OF THE LATTER'S ACT OF BRAVERY, BY REASON OF AND AS A CONSEQUENCE OF WHICH, HE DIED IN LINE OF DUTY.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. In accordance with the declared policy of the City Government of Manila to recognize exemplary deeds of policemen to serve as inspiration and to foster among them the highest ideals of public service, as enunciated by Ordinance No. 7781, approved on February 19, 1993, the amount of FIFTY THOUSAND PESOS (P50,000.00) is hereby appropriated out of any funds existing in the City Treasury, not otherwise appropriated, to be made available for the grant of financial assistance to MRS. HEIDI L. SAYSON, widow of the late SPO3 RICARDO L. SAYSON, JR., former member of the Western Police District Command, in recognition of the latter's act of bravery, by reason of and as a consequence of which, he died in line of duty.


SEC. 2. This Ordinance shall take effect upon its approval.


