

ORDINANCE NO. 7958

AN ORDINANCE RENAMING GANDARA STREET, FROM SOLER TO QUINTIN PAREDES STREETS IN BINONDO, MANILA, SABINO B. PADILLA STREET.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Gandara Street, from Soler to Quintin Paredes streets in Binondo, Manila, is hereby renamed Sabino B. Padilla street.

SEC. 2. The City Engineer is accordingly directed to replace or cause the corresponding replacement of the present street signs installed in strategic places thereat, as follows:

SABINO B. PADILLA
(Gandara)


SEC. 3. Copies of this Ordinance be furnished the Office of the President of the Republic of the Philippines, the Representative of the 3rd Legislative District, and the Philippine Postal Corporation.


SEC. 4. This Ordinance shall take effect immediately upon its approval.
