

ORDINANCE NO. 7960

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 7702 WHICH AUTHORIZED HIS HONOR, THE MAYOR, TO NEGOTIATE FOR THE ACQUISITION EITHER BY EXPROPRIATION OR PURCHASE THROUGH LEGAL MEANS OF CERTAIN PARCELS OF LAND SITUATED IN THE FIRST DISTRICT OF MANILA AND OWNED BY MR. MANUEL SAMIA, FOR RESALE AT COST AND ON INSTALLMENT BASIS NOT EXCEEDING TWENTY YEARS, TO QUALIFIED AND BONA FIDE TENANTS/OCCUPANTS THEREAT, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM, APPROVED ON JUNE 26, 1989.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 3 of Ordinance No. 7702 is hereby amended to read as follows:

"SECTION 3. That the amount of P7,025,000.00 or so much thereof as may be necessary representing the aggregate value of the said parcels of land is hereby appropriated out of the general fund of the City, not otherwise appropriated for the acquisition of the same."


SEC. 2. This Ordinance shall take effect upon its approval.
