

ORDINANCE NO. 7862

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) OUT OF THE GENERAL FUND, TO BE MADE AVAILABLE AS AN ADDITIONAL APPROPRIATION FOR THE CONSTRUCTION OF A TWO-STORY PUBLIC LIBRARY BUILDING, IN BACOOD, STA. MESA, MANILA, IN REPLACEMENT OF THAT WHICH HAS BEEN GUTTED BY FIRE.

Be it ordained by the City Council of Manila, THAT:


SECTION 1. The amount of ONE MILLION PESOS (P1,000,000.00) is hereby appropriated out of the general fund to be made available as additional appropriation for the construction of a two-storey public library building in Bacood, Sta. Mesa, Manila, in replacement of that which has been gutted by fire.


SEC. 2. This Ordinance shall take effect upon its approval.


