

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE MANILA REGIONAL TRIAL COURT, METROPOLITAN TRIAL COURT, AND THE PROSECUTOR'S OFFICE PERSONNEL, APPROPRIATING THE AMOUNT NECESSARY THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy. - It is the policy of the City Government to assist national government employees rendering essential services to the City of Manila and her constituencies.

SEC. 2. Pursuant to this policy, a monthly financial assistance of FIVE HUNDRED PESOS (P500.00) each, effective October 1994, is hereby granted to the Clerks of Court, Branch Clerks of Court and rank-and-file personnel of the Manila Regional Trial Court, Metropolitan Trial Court and the Prosecutor's Office, subject to the existing guidelines on the matter.


SEC. 3. The amount of ONE MILLION EIGHT HUNDRED SEVENTY THREE THOUSAND FIVE HUNDRED PESOS (P1,873,500.00), or so much thereof as may be necessary is hereby appropriated out of any unappropriated funds existing in the City Treasury, to be made available for the payment of said benefit and be it further authorized that the aggregate amount needed to fund the payment of this benefit shall thereafter be incorporated in the annual Executive Budget of the City of Manila.


SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon approval.
