

ORDINANCE NO. 7869

AN ORDINANCE PROVIDING FOR ADDITIONAL ALLOWANCE OF ONE THOUSAND PESOS (P1,000.00) A MONTH TO EACH OF THE CITY ELECTION OFFICERS OF MANILA AND FIVE HUNDRED PESOS (P500.00) A MONTH TO EACH OF THEIR STAFF PERSONNEL, EFFECTIVE OCTOBER, 1994 AND APPROPRIATING THE NECESSARY AMOUNT FOR THEIR OFFICES' OPERATIONAL FUNCTIONS.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. City Election Officers of the City of Manila are hereby given the authority to collect additional allowance of One Thousand Pesos (P1,000.00) a month each, and Five Hundred Pesos (P500.00) a month for each staff personnel effective October, 1994.


SEC. 2. The amount of Four Hundred Sixty-Eight Thousand Pesos (P468,000.00), or so much thereof as may be necessary, is hereby appropriated out of any fund or funds existing in the City Treasury not otherwise appropriated, to cover the aforesaid allowance and their offices' operational functions; PROVIDED, THAT the said amount shall be incorporated in the Annual Executive Budget of the City thereafter.


SEC. 3. This Ordinance shall take effect upon approval.

Enacted by the City Council of Manila at its regular session today November 8, 1994.




