

ORDINANCE NO. 7870

N ORDINANCE PROVIDING FOR THE INCREASE IN THE MONTHLY ALLOWANCE/ASSISTANCE OF THE JUDGES OF THE REGIONAL TRIAL COURT (RTC) AND METROPOLITAN TRIAL COURT (MTC) OF MANILA AND THEIR RESPECTIVE CLERKS OF COURT AND THE GRANT OF MONTHLY ALLOWANCE TO THE ASSISTANT CLERKS OF COURT AND THE BRANCH CLERKS OF COURT; APPROPRIATING THE NECESSARY FUNDS THEREFOR, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The increase in the monthly allowance/assistance of the judges of the Regional Trial Court (RTC) and Metropolitan Trial Court (MTC) of Manila to Five Thousand Pesos (P5,000.00) and their respective Clerks of Court to Two Thousand Five Hundred Pesos (P2,500.00) as well as the grant of monthly allowance to the Assistant Clerks of Court and the Branch Clerks of Court at Two Thousand Pesos (P2,000.00) each, effective October 1994, is hereby authorized.


SEC. 2. The amount of ONE MILLION FIFTY THOUSAND PESOS (P1,050,000.00), or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury, not otherwise appropriated, to be made available for the payment of said allowances, and be it further authorized that the aggregate amount needed to fund the payment of this benefit shall thereafter be incorporated in the annual Executive Budget of the City of Manila.


SEC. 3. This Ordinance shall take effect upon approval.
