

ORDINANCE NO. 7873

AN ORDINANCE GRANTING RELIEF/AMNESTY TO STALLHOLDERS IN PUBLIC MARKETS OF THE CITY OF MANILA FROM SURCHARGES AND PENALTIES ON THEIR RENTAL ARREARAGES FROM NOV. 15, 1994 TO APRIL 30, 1995, UNDER CERTAIN TERMS AND CONDITIONS.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. All stallholders in public markets of the City of Manila are hereby granted relief/amnesty from surcharges and penalties on their rental arrearages and shall be given the period from November 15, 1994 to April 30, 1995, within which to settle their unpaid rentals in the manner prescribed herein.

SEC. 2. Rental arrearages may be paid without surcharges and penalties, as follows:

- a) Fifty percent (50%) of the rental arrearages (excluding the 25% surcharge as provided for in 7a Section 32-C Article V of City Ordinance No. 7794 or the Revenue Code of Manila) shall be paid on or before the 31st day of December 1994.
- b) The remaining fifty percent (50%) is to be paid in equal monthly installments on or before April 30, 1995.

SEC. 3. Stallholders desiring to avail themselves of the said relief/amnesty shall be required to enter into a Rental Relief/Amnesty Compromise Agreement with the City Treasurer, providing therein the terms and conditions stated in the preceding section.


SEC. 4. The City Treasurer shall not accept payments for stall rental arrearages provided for under this Ordinance, unless a valid authority to pay or an order of payment duly signed by his office is presented.


SEC. 5. This Ordinance shall take effect upon its approval. *Dec 7, 1994*


