

ORDINANCE NO. 788/3

AN ORDINANCE GRANTING TO THE DR. JUAN NOLASCO HIGH SCHOOL THE USE OF THE ADJOINING PARCELS OF LAND LOCATED AT THE CORNER OF HERBOSA AND FRANCO STREETS, TONDO, MANILA, OTHERWISE KNOWN AS THE FORMER ONGSIAKO LOT REGISTERED IN THE NAME OF THE CITY OF MANILA UNDER TCT NOS. 30286; 70944; 30284; 70945; AND 70946 AS SCHOOL SITE.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The use of 1,500 square meters, more or less, out of Lot Nos. 1-B-1; 1-B-2; 2-A-1; 2-A-2; and 3-8, otherwise known as the former Ongsiako lot registered in the name of the City of Manila under TCT Nos. 30286; 70944; 30284; 70945; and 70946, and located at the corner of Franco and Herbosa Streets, Tondo, Manila, is hereby granted to the Dr. Juan Nolasco High School for the purpose of constructing a five-storey school building thereon.

SEC. 2. The amount needed for the construction of the five-storey school building shall be taken from the Special Education Fund.


SEC. 3. Effectivity Clause - This Ordinance shall take effect upon its approval.
