

ORDINANCE NO. 7888

AN ORDINANCE PRESCRIBING SANITATION STANDARDS IN TRANSIENT ENTERTAINMENT SHOWS, CIRCUSES, MINI-CARNIVALS, EXPOSITIONS, FAIRS AND SIMILAR BUSINESS ACTIVITIES, AND IN ON-GOING BUILDING CONSTRUCTION SITES, PROVIDING PENALTIES FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. DECLARATION OF POLICY. It is hereby declared the policy of the City of Manila to prescribe sanitation standards covering transient entertainment shows, circuses, mini-carnivals, expositions, fairs and similar business activities and on-going construction sites.

SEC. 2. Pursuant thereto, portable toilets are hereby mandated to be installed in the venues of transient entertainment activities described in Section 1 irrespective of whether the same are in private lots, parking plazas, parks and/or other open public/private places as well as in places where on-going building construction activities are undertaken.

SEC. 3. For the purpose of ensuring order in said venues/sites, portable toilets to be provided shall be separate for male and female and that the waste disposal system for said portable toilets shall be in accordance with the standards to be prescribed by the Manila Health Department.

SEC. 4. No permit for the holding of the aforesaid activities shall be issued without any proof of compliance with Sections 2 and 3 of this Ordinance, as certified by the City Health Officer.

SEC. 5. PENALTY. Violation of this Ordinance shall be punished by imprisonment of one (1) year or a fine of Five Thousand Pesos (P5,000.00), or both, upon the discretion of the court.


SEC. 6. REPEALING CLAUSE. All ordinances or portions thereof which are contrary or inconsistent with this Ordinance, are hereby deemed repealed or modified accordingly.


SEC. 7. EFFECTIVITY. This Ordinance shall take effect upon its approval.
