ORDINANCE HO. 73

AN ORDINANCE AUTHORIZING HIS HONOR, MAYOR ALFREDO S. LIM, TO ACQUIRE EITHER BY NEGOTIATION OR EXPROPRIATION, A PARCEL OF LAND COVERED BY TCT NOS. 111144, 111145, 111146, 111147, 114706, 114707, 114708 AND 114705 LOCATED AT ARAGON STREET AND PASIG LINE STREET, STA. ANA, MANILA, FOR AWARD TO THE ACTUAL BONA FIDE RESIDENTS THEREAT AND APPROPRIATING THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00) FOR THE PURPOSE.

Be it ordained by the City Council of Manila, THAT:

- SECTION 1. In line with the Home-for-the-Homeless program of the City Government, the City Mayor is hereby authorized to acquire, either by negotiation or expropriation, a parcel of land covered by TCT Nos. 111144, 111145, 111146, 111147, 114706, 114707, 114708 and 114705, located at Aragon Street and Pasig Line Street, Sta. Ana, Manila, for award to the actual bona fide residents thereat.
- SEC. 2. The amount of SIX MILLION PRSOS (P6,000,000.00), or so much thereof as may be necessary, is hereby appropriated out of any existing available funds in the City Treasury for the purpose of acquiring the abovementioned property.
- SEC. 3. The City Housing and Urban Development Board, in coordination with the Urban Settlements Office, shall cause and oversee the acquisition of the above-mentioned property and the distribution thereof to the actual and bone fide tenants in accordance with existing policies and guidelines on the matter.
 - SEC. 4. This Ordinance shall take effect upon approval.
