## **ORDINANCE NO. 8386**

**AN ORDINANCE GRANTING ALLOWANCE TO THE BARANGAY CHAIRMEN OF ALL THE COMPONENT BARANGAYS WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF MANILA AND APPROPRIATING THE NECESSARY FUNDS THEREOF**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** A monthly allowance of One Thousand Pesos (PhP. 1,000.00), is hereby granted to the barangay chairmen of all the component barangays within the territorial jurisdiction of the City of Manila, which amount shall be released to them on a quarterly basis, necessary to carry out the intention of this Ordinance is included and authorized through Executive Budget of CY 2015.


**SEC. 2.** The necessary amount to defray said allowances has been appropriated through City Ordinance No. 8372.

**SEC. 3. Repealing Clause.** – All ordinances, rules and regulations or portions thereof which are contrary to the provisions of this Ordinance or portions hereof are deemed modified and repealed.

**SEC. 4. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 29, 2015.
