ORDINANCE NO. 8602

AN ORDINANCE APPROPRIATING THE AMOUNT OF NINETY MILLION THREE HUNDRED TEN THOUSAND PESOS (PHP. 90,310,000.00), AS GENERAL FUND SUPPLEMENTAL BUDGET NO. 3, TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATIONS OF THE CITY OF MANILA FOR THE SERVICE RECOGNITION INCENTIVE PURSUANT TO ADMINISTRATIVE ORDER NO. 19 FOR CALENDAR YEAR 2019

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. There is hereby appropriated from the General Fund, sourced from Reversion of Appropriations, and which are not otherwise appropriated, the sum of Ninety Million Three Hundred Ten Thousand Pesos (PhP. 90,310,000.00), as General Fund Supplemental Budget No. 3, and which budget documents, marked as Annex "A", for Statement of Funding Sources (LBP Form No. 8), and Annex "B", for Statement of Supplemental Appropriation (LBP Form No. 9), are attached and made integral parts hereof, to be made available as additional appropriations of the City Government of Manila for Calendar Year 2019.

The herein appropriation of funds represents the authorized supplemental budgetary support for the payment of Other Personnel Benefits (Service Recognition Incentive under Administrative Order No. 19 of the Office of the President of the Philippines dated 02 December 2019) of city government personnel and which are incorporated in the following items of expenditures.
