ORDINANCE NO. 8615

AN ORDINANCE PROVIDING MONETARY REWARD TO QUALIFIED MANILA DAY CARE TEACHERS UNDER THE MANILA DEPARTMENT OF SOCIAL WELFARE IN THE CITY OF MANILA, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, the National Government, through the Department of Social Welfare and Development, in prioritizing its commitment to human development concerns of children, as a response to the country's ratification of the Convention of the Rights of Children on July 26, 1990, recognizes the role of Day Care Service and other Early Childhood Care and Development programs for their well-being;

WHEREAS, Day Care Teachers are tasked to take care of children of the City of Manila under the Early Childhood Care and Development program;

WHEREAS, despite the delicate and important role of Day Care Teachers, they do not have plantilla items in government;

WHEREAS, despite their predicament, they continue to nurture and educate children like their own: an invaluable role in rearing of the next generation of Manileños that needs to be rewarded;

WHEREAS, in recognition of the Day Care Teachers' tireless commitment to their students, the City of Manila intends to reward them as they end their service absent the benefits given to regular government employees: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. TITLE. – This Ordinance shall be known as “**THE DAY CARE TEACHERS WELFARE ORDINANCE OF 2020**” for brevity.

SEC. 2. BENEFICIARY OF THIS ORDINANCE. – Day Care Teachers under the MDSW shall qualify to benefit from this Ordinance under the following conditions:

- 1) rendered at least fifteen (15) years of service as Day Care Teachers in the City of Manila; or
- 2) have reached sixty (60) years old and provided that the Day Care Teacher has rendered at least ten (10) years of service as Day Care Teacher in the City of Manila under the MDSW.

SEC. 3. MONETARY REWARD. – Monetary Reward, which shall be availed of only once, shall be given to the following:

- a. THIRTY THOUSAND PESOS (PhP. 30,000.00) to the Day Care Teacher who has reached sixty (60) years old, PROVIDED, that the said beneficiary has rendered at least ten (10) years of service as Day Care Teacher in the City of Manila under the MDSW; and
- b. FIFTY THOUSAND PESOS (PhP. 50,000.00) to the Day Care Teacher who has rendered at least fifteen (15) years of service as Day Care Teacher in the City of Manila under the MDSW.

Further, a plaque of appreciation recognizing their years of service will be given together with the monetary reward.

SEC. 4. APPROPRIATION. – The City Government shall appropriate funds which shall be used for purposes mandated by this Ordinance in the city's Annual Executive Budget and in every succeeding budget year thereafter.


SEC. 5. SEPARABILITY CLAUSE. – If any provision of this Ordinance or the application of such provision to other persons or circumstances is declared invalid, the provisions thereof not affected thereby shall remain in full force and effect.

SEC. 6. REPEALING CLAUSE. – All ordinances, resolutions, executive orders, rules and regulations, and other issuances or parts thereof found to be inconsistent with the provisions of this Ordinance are hereby repealed, modified or amended accordingly.


SEC. 7. EFFECTIVITY CLAUSE. – This Ordinance shall take effect upon its approval and after publication in a newspaper of general circulation.

This Ordinance was finally enacted by the City Council of Manila on March 2, 2020.


