AN ORDINANCE CREATING SEVENTY-FIVE (75) REGULAR PLANTILLA ITEMS
FOR OSPITAL NG MAYNILA MEDICAL CENTER AND APPROPRIATING FUNDS
THEREFORE

PREAMBLE

WHEREAS, the present COVID-19 Pandemic has greatly burdened local hospitals with the increasing number of its victims;

WHEREAS, to sustain the services provided by public hospitals, there is an urgent need to increase the number of medical personnel being employed;

WHEREAS, this increase of available regular plantilla positions, particularly in its Nursing, Medical and Administrative divisions, is in accordance with the guidelines issued by the Department of Health for Tertiary Hospitals;

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. NEW PLANTILLA POSITIONS. – The following new positions are hereby created under the different offices and departments of Ospital ng Maynila Medical Center:

SEC. 2. QUALIFICATIONS, POWERS AND DUTIES/RESPONSIBILITIES. – The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC), the Medical Act and other relevant laws.

SEC. 3. APPOINTMENTS. – The employment and appointment of individuals for the herein subject positions shall be within the qualification, standard and guidelines set by the Department of Health, Civil Service Commission (CSC), and other relevant agencies.


SEC. 4. APPROPRIATION OF FUNDS. – Funds necessary for the immediate implementation of this ordinance shall be sourced from any available fund unappropriated under the 2020 Executive Budget. Further, herein subject positions shall be automatically funded through the succeeding annual city budget as part of Ospital ng Maynila Medical Center plantilla.

SEC. 5. REPEALING CLAUSE. – Any provisions of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended or modified accordingly.

SEC. 6. EFFECTIVITY CLAUSE. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on April 23, 2020.
