## **ORDINANCE NO. 8662**

AN ORDINANCE APPROPRIATING THIRTY MILLION PESOS (PHP. 30,000,000.00) AS SUPPLEMENTAL BUDGET NO. 14, FOR FISCAL YEAR 2020 TO COVER EXPENSES FOR HIGH PRESSURE WASHING OPERATIONS, CLEARING, DISINFECTING, AND DISPOSAL OF WASTE FOR THE ENTIRE CITY OF MANILA

WHEREAS, earlier today, the local legislative body approved Resolution No. 14, Series of 2020, adopted by the Executive Committee of the City Development Council on August 19, 2020, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM OR ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2020 IN CONNECTION WITH THE CITY OF MANILA'S ACTION PLAN AGAINST COVID-19 SPECIFICALLY THE PROVISION FOR ENVIRONMENT/SANITARY SERVICES TO CONTAIN THE SPREAD OF COVID-19 IN THE AMOUNT OF THIRTY MILLION PESOS (PHP. 30,000,000.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in special session assembled, THAT;

**SECTION 1.** The Supplemental Budget of the City Government of Manila for Fiscal Year 2020 in the amount of **Thirty Million Pesos (PhP. 30,000,000.00)** is hereby approved.

**SEC. 2. Source of Funds.** - The source of funds for the Supplemental Budget in the total amount of **Thirty Million Pesos (PhP. 30,000,000.00)** shall be derived from the following source:

- SEC. 3. Use of Funds. The amount of Thirty Million Pesos (PhP. 30,000,000.00) is hereby appropriated for the Supplemental Budget of the City Government of Manila under the Department of Public Services with the following appropriations:
  - 1. Environment/Sanitary Services in the amount of **Thirty Million Pesos** (**PhP. 30,000,000.00**) for high pressure washing operations, clearing, disinfecting, and disposal of waste for the entire City of Manila;
- **SEC. 4. Effectivity Clause**. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 20, 2020.
