**ORDINANCE NO. 8664**

**AN ORDINANCE** AMENDING THE PLANTILLA OF PERSONNEL AND PERSONNEL SCHEDULE OF THE GAT ANDRES BONIFACIO MEMORIAL MEDICAL CENTER BY RETITLING SEVERAL ADMINISTRATIVE POSITIONS TO THEIR SPECIFIC TECHNICAL FUNCTIONS IN CONFORMITY WITH THE DBM BUDGET CIRCULAR NO. 2004-3 RELATIVE TO THE NON-CONVERSION OF POSITIONS IN CASE OF DIFFERENT QUALIFICATION STANDARDS

## PREAMBLE

WHEREAS, the Department of Budget and Management (DBM) released Budget Circular No. 2004-3 relative to the conversion of positions performing staff/non-technical functions in agencies of the national government, government-owned or -controlled corporations and local government units;

WHEREAS, in the same Circular, DBM qualified that some Plantilla positions shall not be converted or contain general administrative positions under the Administrative Service Group if these positions cannot be classified to specific classes since they have different qualification standards and are performing exclusive technical functions;

WHEREAS, the Gat Andres Bonifacio Memorial Medical Center has several such technical administrative positions to which their duties and responsibilities are not part of the overall primary mandate of the hospital;

WHEREAS, the current Plantilla of Personnel indicates these general administrative position titles with the parenthetical positions and which appointments may possibly be invalidated by the Civil Service Commission (CSC) based on existing jurisprudence;

WHEREAS, it is the policy of the City Government of Manila to comply with the prescribed rules and regulations contained under DBM Circular No. 2004-3 regarding the proper classification and titling of plantilla positions performing staff/technical functions;

WHEREAS, the Position Titles of the subject positions performing technical functions in the Gat Andres Bonifacio Memorial Medical Center were requested to be converted by Dr. Teodoro E. Martin, Officer-in-Charge/Hospital Director in a letter to His Honor the Mayor dated 30 August 2020;

WHEREAS, no salary rate adjustment will accrue upon the retitling of the foregoing amended Plantilla positions as they will continue to retain their existing Salary Grade levels: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** The following positions in the Plantilla of Personnel and Personnel Schedule of the Gat Andres Bonifacio Memorial Medical Center shall be retitled as follows:

**SEC. 2. Separability Clause.** – Should any provision herein be declared unconstitutional, the same shall not affect the validity of the other provisions of this Act.

**SEC. 3. Repealing Clause.** – All laws, decrees, orders, rules and other regulations or other issuances or parts inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 4. Effectivity clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 20, 2020.
