## **ORDINANCE NO. 8665**

AN ORDINANCE FURTHER AMENDING ORDINANCE NOS. 8647, 8616 BY IMPOSING THE CURFEW IN THE CITY OF MANILA ACCORDING TO THE QUARANTINE CLASSIFICATIONS

## PREAMBLE

WHEREAS, on August 18, 2020, President Rodrigo Roa Duterte declared that Metro Manila will once again be under General Community Quarantine (GCQ) from August 19-31, 2020;

WHEREAS, previous curfew hours under GCQ started at Ten in the evening (10:00 pm) until Five in the morning (5:00 am);

WHEREAS, in order to continue the gains in the efforts placed during the last MECQ, it is recommended that curfew hours under MECQ stay the same even under GCQ: NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** Section 1 of Ordinance No. 8616, amended by Ordinance No. 8647, is hereby amended and shall now read as follows:

SECTION 1. Imposition Of Curfew Hours; Covered Persons – Unless otherwise provided by the IATF, there is hereby imposed curfew hours for all persons in the City of Manila, depending on the quarantine classification of the National Capital Region, to wit:

Enhanced Community Quarantine - between Eight O'clock in the evening (8:00 pm) to Five O'clock in the morning (5:00 am).

Modified Enhanced Community Quarantine - between Eight O'clock in the evening (8:00 pm) to Five O'clock in the morning (5:00 am).

General Community Quarantine – <u>between Eight O'clock in the evening (8:00 pm)</u> to Five O'clock in the morning (5:00 am).

- SEC. 2. Exceptions <u>During curfew hours, no person shall be allowed in the streets, commercial establishments, recreation centers, malls or any other areas outside the immediate vicinity of their residence, except the following:</u>
  - Authorized Persons Outside of Residence (APOR) for purposes of this Ordinance, APOR are those persons allowed by the IATE to be outside of their residence;
  - b. In case of any medical and humanitarian emergency;

- Fast food restaurants and/or food chains that are allowed to open beyond curfew hours and/or 24 hours;
- d. Employees and delivery personnel for restaurants/food chains allowed to open beyond curfew hours and/or 24 hours;
- e. Work related travels;
- For purpose of transiting to the airport for international travel.

SEC. 2. EFFECTIVITY. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 20, 2020.
