## **ORDINANCE NO. 8674**

AN ORDINANCE AUGMENTING THE PERSONAL SERVICES – PHILHEALTH CONTRIBUTIONS ACCOUNT OF THE DIFFERENT DEPARTMENTS / OFFICES / BUREAUS IN THE TOTAL AMOUNT OF NINE MILLION TWO HUNDRED SEVENTY THOUSAND SIX HUNDRED SIXTY-THREE PESOS (PHP. 9,270,663.00) FROM THE PERSONAL SERVICES SAVINGS OF VARIOUS DEPARTMENTS / OFFICES / BUREAUS TO FUND THE INCREASE IN THE PHILHEALTH CONTRIBUTIONS IN ACCORDANCE WITH THE PHILHEALTH CIRCULAR NO. 2019-0009 DATED OCTOBER 25, 2019, ENTITLED: "PREMIUM CONTRIBUTION SCHEDULE IN THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP) PURSUANT TO R.A. NO. 11223 KNOWN AS THE UNIVERSAL HEALTH CARE ACT."

## PREAMBLE

WHEREAS, On October 25, 2019, the Philippine Health Insurance Corporation (Philhealth) issued Philhealth Circular No. 2019-0009, entitled: "Premium Contribution Schedule in the National Health Insurance Program (NHIP) Pursuant to R.A. No. 11223 known as the Universal Health Care Act", which prescribed an increase in the premium contribution rate from 2.75% in 2019 to 3% in 2020;

WHEREAS, Section 336 of Republic Act No. 7160, or the Local Government Code of 1991, provided that "..the local chief executive or the presiding officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Augmentation of Philhealth Contributions. - The appropriations for Personnel Services — Philhealth Contributions Account of various Departments/Offices/Bureaus shall be augmented in the total amount of Nine Million Two Hundred Seventy Thousand Six Hundred Sixty-Three Pesos (PhP. 9,270,663.00) to fund the increase in Philhealth Contributions of the City Government of Manila pursuant to Philhealth Circular No. 2019-0009, prescribing the "Premium Contribution Schedule in the National Health Insurance Program (NHIP) Pursuant to R.A. No. 11223 known as the 'Universal Health Care Act.'"

SEC. 2. Personal Services Savings as Fund Source. - The amount necessary to fund the augmentation of Philhealth Contributions shall be sourced from the Personal Services Savings from January 1, 2020 to June 30, 2020 of the different Departments/Offices/Bureaus as follows:

- **SEC. 3. Separability Clause.** If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.
- SEC. 4. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on September 7, 2020.
