ORDINANCE NO. 8675

AN ORDINANCE APPROPRIATING ONE HUNDRED THIRTY TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP. 132,500,000.00) AS SUPPLEMENTAL BUDGET NO. 16 FOR FISCAL YEAR 2020 UNDER THE MANILA DEPARTMENT OF SOCIAL WELFARE TO COVER WELFARE GOODS EXPENSES INTENDED FOR FAMILIES RESIDING IN MANILA WHO ARE AFFECTED BY THE COVID-19 PANDEMIC

PREAMBLE

WHEREAS, on 8 March 2020 Presidential Proclamation No. 922, s. 2020, was issued declaring a State of Public Health Emergency throughout the Philippines due to the Coronavirus Disease 2019 (COVID-19) and the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases.

In view of the continuing rise of confirmed cases of COVID-19, the serious threat to the health, safety, security, and lives of our countrymen, the long-term adverse effects on their means of livelihood, and the severe disruption of economic activities, a state of national emergency is hereby declared over the entire country.;

WHEREAS, the said Proclamations enjoined all government agencies and Local Government Units (LGUs) to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, the Local Government Code of 1991 states that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants" (*Section 16 of Republic Act No. 7160*);

WHEREAS, the same Code provides that "All budgetary proposals shall be included and considered in the budget preparation process. After the local chief executive concerned shall have submitted the executive budget to the sanggunian, no ordinance providing for a supplemental budget shall be enacted, except when supported by funds actually available as certified by the local treasurer or by new revenue sources". (*Section 321 par. 1 of Republic Act No. 7160*);

WHEREAS, earlier today, the local legislative body approved Resolution No. 17, Series of 2020, adopted by the Executive Committee of the City Development Council on September 10, 2020, entitled: "A Resolution Approving the Amendment of the Annual Investment Program or Issuance of a Supplemental Investment Program for FY 2020 to cover the Welfare Goods Expenses Intended for Families Residing in Manila Who are Affected by the Covid-19 Pandemic in the Total Amount of One Hundred Thirty Two Million Five Hundred Thousand Pesos (PhP. 132,500,000.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The Supplemental Budget of the City Government of Manila for Fiscal Year 2020 in the amount of One Hundred Thirty Two Million Five Hundred Thousand Pesos (PhP. 132,500,000.00) is hereby approved.

SEC. 2. Source of Funds. – The source of funds for the Supplemental Budget in the total amount of One Hundred Thirty Two Million Five Hundred Thousand Pesos (PhP. 132,500,000.00) shall be derived from the following source:

New Revenue Source

Patrimonial = Sale of Property ₱ 132,500,000.00


SEC. 3. Use of Funds. – The amount of One Hundred Thirty Two Million Five Hundred Thousand Pesos (PhP. 132,500,000.00) is hereby appropriated for the Supplemental Budget of the City Government of Manila under the Manila Social Welfare Department with the following appropriations:

1. Maintenance & Other Operating Expenses – to cover Welfare Goods Expenses intended for families residing in Manila who are affected by the Covid-19 Pandemic in the total amount of One Hundred Thirty Two Million Five Hundred Thousand Pesos (PhP132,500,000.00).


SEC. 4. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on September 14, 2020.




