## **ORDINANCE NO. 8693**

AN ORDINANCE COLLAPSING TWENTY-SEVEN VARIOUS VACANT POSITIONS IN THE UNIVERSIDAD DE MANILA THROUGH THE SCRAP-AND-BUILD STRATEGY UNDER THE GOVERNMENT'S RATIONALIZATION PROGRAM AND THEREBY CREATING TWELVE NEW PLANTILLA ITEMS

## PREAMBLE

WHEREAS, it is the policy of the City of Manila, in consonance with the policy of the State, to genuinely be committed in promoting the right of all citizens to quality education at all levels;

WHEREAS, Universidad de Manila (UdM) is an institutional department of the City of Manila pursuant to MCO 7885, as amended by MCO 8120;

WHEREAS, MCO 8635, granted UdM control over the "management of fiscal, human resources, and all other assets";

WHEREAS, pursuant to MCO 8635, Section 26, UdM submitted to the Mayor its Enhanced Organizational Structure as approved by its Board of Regents in Resolution No. 48;

WHEREAS, it is the policy of Universidad de Manila to always maintain and ensure economy, efficiency, and effectiveness in its operations;

WHEREAS, the effectiveness of the various offices in Universidad de Manila must be enhanced through a streamlining of plantilla positions, which would make the provision of its service to the public more efficient and effective;

WHEREAS, Section 2.5 of Civil Service Commission Memorandum Circular No. 19, Series of 992, provides that: "In cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition shall be made in accordance with pertinent provisions of this Code and the civil service law, rules and regulations";

WHEREAS, the Executive Committee on the Rationalization Program composed of the Department of Budget and Management (DBM) and CSC in 12 May 2006, came out with Resolution No. 1 which laid down as part of the Allowable Staffing Actions the following, (a) Abolition of positions, (b) Conversion of positions, (c) Reclassification of positions, (d) Retitling of positions, and (e) Creation of positions whereby the *scrap and build policy* must be observed when new positions may be created as long as there are corresponding obsolete/unnecessary but funded positions can be abolished to support the creation of these new positions;

WHEREAS, the generated savings from the scrapped positions will be enough to cover the computed amount needed to fund the created positions and that the total amount for Personal Services, including the new positions, will not exceed the 45% statutory limitation on the total approved annual appropriation: NOW, THEREFORE,



Be it ordained by the City Council of Manila, in special session assembled, THAT;

**SECTION 1. Collapsed Plantilla Positions.** – The following positions are hereby abolished under Universidad de Manila:

SEC. 3. Qualifications, Powers and Duties/Responsibilities. — The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC) and other relevant laws.

- SEC. 4. Appointment. The employment and appointment of the individuals for herein subject positions shall be within the qualification standard and guidelines set by the Civil Service Commission (CSC) and other relevant agencies.
- SEC. 5. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.
  - SEC. 6. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 26, 2020.
