# **ORDINANCE NO. 8720**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BALUT-TODA DISTRICT 1-INC. (BALTODA-1) AND SECTION 2 OF ORDINANCE NO.7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

HON. MACARIO M. LACSON Acting Majority Floor Leader Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of BALUTTODA DISTRICT 1 – INC. (BALTODA-1), to read as follows:

# "BALUT-TODA DISTRICT 1 - INC. (BALTODA-1)

## **Loading and Unloading Areas**

a. Nepa-Malaya-Rodriguez-Guidote Balut"

**SEC. 2.** Section 2 of Ordinance No. 7871, is hereby furthermore amended, by Including therein the Route Measure Capacity and authorized route line of BALUTTODA DISTRICT 1 – INC. (BALTODA), to read as follows:

### "ASSOCIATION

**RMC** 

BALUTTODA, DISTRICT 1, INC. (BALTODA)

300 Units

#### ROUTE

The authorized route lines of operation shall be via Nepa-Malaya-Rodriguez-Guidote Balut, Tondo, Manila."

- Sec. 3. Separability Clause If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.
- SEC. 4. Repealing Clause All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinanace are hereby repealed or modified accordingly.
  - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 7, 2021.
