AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BALUT-TODA DISTRICT 1-INC. (BALTODA-1) AND SECTION 2 OF ORDINANCE NO.7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading areas of BALUT-TODA DISTRICT 1 – INC. (BALTODA-1), to read as follows:

“BALUT-TODA DISTRICT 1 – INC. (BALTODA-1)

Loading and Unloading Areas

a. Nepa-Malaya-Rodriguez-Guidote Balut”

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by Including therein the Route Measure Capacity and authorized route line of BALUT-TODA DISTRICT 1 – INC. (BALTODA), to read as follows:

“ASSOCIATION

RMC

BALUTTODA, DISTRICT 1, INC.
(BALTODA)

300 Units

ROUTE

The authorized route lines of operation shall be via Nepa-Malaya-Rodriguez-Guidote Balut, Tondo, Manila.”

Sec. 3. Separability Clause – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

SEC. 4. Repealing Clause – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.


