RECEPTIONIST II, THREE (3) ADMINISTRATIVE AIDE IV AND TWO (2)

PREAMBLE

WHEREAS, on 28 January 2021, Mr. Charlie DJ Duño, Officer-in-Charge and Protocol Officer of the Department of Tourism, Culture and Arts of Manila (DTCAM), submitted a letter requesting for the amendment of Ordinance No. 8683;

Be it ordained by the City Council of Manila, in session assembled, THAT:


SECTION 1. Section 2 of Ordinance No. 8683, is hereby amended to read as follows:
