AN ORDINANCE AUTHORIZING FY 2022 SUPPLEMENTAL BUDGET NO. 3 FOR THE PAYMENT OF THE FY 2021 OTHER PROFESSIONAL SERVICES OF THE UNIVERSIDAD DE MANILA IN THE AMOUNT OF FIVE MILLION NINE HUNDRED TWENTY-EIGHT THOUSAND FORTY-THREE PESOS (PHP. 5,928,043.00) AND FOR OTHER PURPOSES

PREAMBLE

WHEREAS, every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the enhancement of economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants [Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991];

WHEREAS, local government units shall likewise exercise such powers and discharge such functions and responsibilities for the efficient and effective provision of basic services and facilities which includes among others support for education (Section 17 of R.A. No. 7160);

WHEREAS, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160);

WHEREAS, the City Council likewise approved Resolution No. 04, Series of 2022, of the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR THE PAYMENT OF THE FY 2021 OTHER PROFESSIONAL SERVICES OF THE UNIVERSIDAD DE MANILA IN THE AMOUNT OF FIVE MILLION NINE HUNDRED TWENTY-EIGHT THOUSAND FORTY-THREE PESOS (PHP. 5,928,043.00)": NOW, THEREFORE,

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Appropriations. - The FY 2022 Supplemental Budget of the City of Manila in the total amount of Five Million Nine Hundred Twenty-Eight Thousand Forty-Three Pesos (PhP. 5,928,043.00) is hereby appropriated to fund the expenditure of the City of Manila, to wit;

SEC. 2. Separability Clause. – If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.


SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.


