AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF CARLOS PALANCA-QUIAPO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC., AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of CARLOS PALANCA-QUIAPO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC., to read as follows:

"CARLOS PALANCA-QUIAPO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC.

Loading and Unloading Areas

- a. 174 Marawi Lodge Talipapa St., Terminal
- b. C. Palanca Street
- c. Islamic Center, San Miguel
- d. P. Casal Street, Quiapo, Manila
- **SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of CARLOS PALANCA-QUIAPO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC., to read as follows:

"ASSOCIATION

R.M.C.

CARLOS PALANCA - QUIAPO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION INC. 100 Units

ROUTE

The authorized route lines of operation shall be via 174 Marawi Lodge Talipapa St., Terminal – C. Palanca Street – Islamic Center, San Miguel – P. Casal Street, Quiapo, Manila and vice-versa."

- **SEC. 3. Separability Clause.** If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
