# **ORDINANCE NO. 8829**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF KAGITINGAN TRICYCLE OPERATORS AND DRIVERS ASSN. (KAGITODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of KAGITINGAN TRICYCLE OPERATORS AND DRIVERS ASSN. (KAGITODA) INC., to read as follows:

# "KAGITINGAN TRICYCLE OPERATORS AND DRIVERS ASSN. (KAGITODA) INC.

### **Loading and Unloading Areas**

- a. Kagitingan St. cor. Tuazon St.
- b. Delpan St. cor. Zaragoza St.
- c. Moriones St. cor. Wagas St.
- d. Zaragoza St. cor. Road 10 St.
- e. Tutuban St. cor. Moriones St."
- **SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of KAGITINGAN TRICYCLE OPERATORS AND DRIVERS ASSN. (KAGITODA) INC., to read as follows:

#### "ASSOCIATION

R.M.C.

KAGITINGAN TRICYCLE OPERATORS AND DRIVERS ASSN. (KAGITODA) INC.

100 Units

#### ROUTE

The authorized route lines of operation shall be via Kagitingan St. going Zaragoza St., to Moriones St., to Tutuban St. and vice-versa."

- **SEC. 3. Separability Clause**. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
  - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
