ORDINANCE NO. 8830

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF ERMALU-TODA INCORPORATED AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended is hereby furthermore amended, by including therein the loading and unloading areas of ERMALU-TODA INC., to read as follows:

"ERMALU-TODA INCORPORATED

Loading and Unloading Areas

- a. Ma. Orosa (Jollibee)
- b. Mabini St., corner Kalaw
- c. Manila Ocean Park, Quirino Grandstand
- d. Mabini corner Gen. Luna St.
- e. T.M. Kalaw (beside Methodist Church)
- f. Katigbak, Roxas Blvd."

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of ERMALU-TODA INCORPORATED, to read as follows:

"ASSOCIATION

RMC

ERMALU-TODA INCORPORATED

100 Units

ROUTE

The authorized route lines of operation shall begin in the area of Ma. Orosa (Jollibee)-Mabini corner Kalaw-Manila Ocean Park, Quirino Grandstand-Mabini corner Gen. Luna-T.M. Kalaw (beside Methodist Church)-Katigbak, Roxas Blvd. and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.
