**ORDINANCE NO. 8833**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PACO MARKET BRGY. 673 Z-73 TODA MANILA CITY INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of PACO MARKET BRGY. 673 Z-73 TODA MANILA CITY INC., to read as follows:

**“PACO MARKET BRGY. 673 Z-73 TODA MANILA CITY INC.**

**Loading and Unloading Areas**

- a. Gen. Luna/Pedro Gil Sts.
- b. Escoda/A. Linao Sts.
- c. Pedro Gil/Singalong Sts.”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of PACO MARKET BRGY. 673 Z-73 TODA MANILA CITY INC., to read as follows:

**“ASSOCIATION**

**RMC**

PACO MARKET BRGY. 673 Z-73  
TODA MANILA CITY INC.

120 Units

**ROUTE**

The authorized route lines of operation shall begin in the area of Pedro Gil St. Gen. Luna St. - Perez - St. Apacible St. San Marcelino St. Malvar St. Singalong St. Nakpil St. Benitez St. Escoda St. A. Linao St. Mindoro St. Chabelita St. and vice-versa.”


**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 24, 2022.


