ORDINANCE NO. 8886

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF RODRIGUEZ MALAYA NEPA TODA (ROMANE TODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of RODRIGUEZ MALAYA NEPA TODA (ROMANE TODA) INC., to read as follows:

"RODRIGUEZ MALAYA NEPA TODA (ROMANE TODA) INC.

Loading and Unloading Areas

- 1. Honorio Lopez Boulevard cor. Rodriguez Street
 - a. Rodriguez Street cor. Nepa Street
 - b. Rodriguez Street cor. Malaya Street
- 2. Honorio Lopez Boulevard cor. Simeon de Jesus Street
 - a. Simeon de Jesus Street cor. Nepa Street
- 3. Rodriguez Street cor. Banahaw Street
 - a. Banahaw Street cor. Paulino Street"

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of RODRIGUEZ MALAYA NEPA TODA (ROMANE TODA) INC., to read as follows:

"ASSOCIATION

R.M.C.

RODRIGUEZ MALAYA NEPA TODA (ROMANE TODA) INC.

100 Units

ROUTE

The authorized route lines of operation shall begin in the area of Honorio Lopez Boulevard to Rodriguez Street to Honorio Lopez Boulevard to Simeon de Jesus Street to Rodriguez Street to Banahaw Street to Paulino Street and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on July 7, 2022.
