AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PNR-22DAG TODA INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, aas amended, is hereby furthermore amended, by including therein the loading and unloading areas of PNR-22DAG TODA INC., to read as follows:

"PNR-22DAG TODA INC.

Loading and Unloading Areas

PNR Compound - Mayhaligue Road

- a. Dagupan Road
- b. Perfecto Street
- c. Moriones Street
- d. Franco Street
- e. Sta. Maria Street
- f. Varona Street
- g. Herbosa Street
- h. Yangco Street

- i. C.P. Garcia Street
- i. N. Zamora Streer
- k. Mel Lopez Street
- I. Asuncion Street
- m. Lakandula Street
- n. Zaragosa Street
- o. Kagitingan Street"

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of PNR-22DAG TODA INC., to read as follows:

"ASSOCIATION

R.M.C.

PNR-22DAG TODA INC.

150 Units

ROUTE

The authorized route line of operation for PNR-22DAG TODA INC. shall be via PNR Compound – Mayhaligue Road to Dagupan Road to Perfecto St. to Moriones St. to Franco St. to Sta. Maria St. to Varona St. to Herbosa St. to Yangco St. to C.P. Garcia St. to N. Zamora St. to Mel Lopez St. to Asuncion St. to Lakandula St. to Zaragosa St. to Kagitingan St. and vice versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause. -** All other local laws, decrees, orders, issuances rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.
- SEC. 5. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on July 7, 2022.
