AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BARRIO MAGSAYSAY TONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BOMAG TODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of BARRIO MAGSAYSAY TONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BOMAG TODA) INC., to read as follows:

“BARRIO MAGSAYSAY TONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BOMAG TODA) INC.

Loading and Unloading Areas

- a. Garcia St. corner Pacheco St.
- b. Pacheco St. corner Quezon St.
- c. Garcia St. corner Herbosa St.
- d. Quezon St. corner Moriones St.
- e. Moriones St. corner Dagupan St.”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of BARRIO MAGSAYSAY TONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BOMAG TODA) INC., to read as follows:

“ASSOCIATION

R.M.C

BARRIO MAGSAYSAY TONDO
TRICYCLE OPERATORS AND DRIVERS
ASSOCIATION (BOMAG TODA) INC.

60 Units

ROUTE

The authorized route lines of operation shall be via Garcia St. to Pacheco St., Pacheco St. to Quezon St., Garcia St. to Herbosa St., Quezon St. to Moriones St., Moriones St. to Dagupan St. and vice versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and affect.


SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on July 7, 2022.
