AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF JUAN NOLASCO MORGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (JM TODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of JUAN NOLASCO MORGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (JM TODA) INC., to read as follows:

“JUAN NOLASCO MORGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (JM TODA) INC.

Loading and Unloading Areas

- A. J. Nolasco St. corner Morga St.
- B. J. Nolasco St. corner Moriones St.
- C. J. Nolasco St. corner Chacon St.
- D. Pacheco St. corner Madrid St.
- E. Zaragoza St. corner Delpa St.”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of JUAN NOLASCO MORGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (JM TODA) INC., to read as follows:

<u>“ASSOCIATION</u>	<u>R.M.C.</u>
JUAN NOLASCO MORGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (JM TODA) INC.	30 Units

ROUTE

The authorized route line of operation for JUAN NOLASCO MORGA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (JM TODA) INC. shall be via J. Nolasco St. to Morga St., J. Nolasco St. to Moriones St., J. Nolasco St. to Chacon St., Pacheco St. to Madrid St., Zaragoza St., to Corner Delpa St. and vice versa.”


SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SEC. 4. Repealing Clause. - All other local laws, decrees, orders, issuances rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.



SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on July 7, 2022.
