**ORDINANCE NO. 8897**

**AN ORDINANCE** FURTHER AMENDING SECTION 2 OF CITY ORDINANCE NO. 8073, AS AMENDED BY CITY ORDINANCE NO. 8333, BY FURTHER INCREASING THE APPROPRIATED AMOUNT THEREON TO TWO HUNDRED SIXTY-FOUR MILLION SEVEN HUNDRED SEVENTY SIX THOUSAND PESOS (PHP. 264,776,000.00), TO BE CHARGED UNDER THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA AUTHORIZED BY VIRTUE OF SUPPLEMENTAL BUDGET NO. 1 FY 2022

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** - Section 2 of Ordinance No. 8073, enacted by the City Council on January 29, 2004 and approved by the Mayor on February 19, 2004, entitled: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ACQUIRE EITHER BY PURCHASE, NEGOTIATION OR EXPROPRIATION A PARCEL OF LAND WITH AN AREA OF 6,619.4 SQUARE METERS, MORE OR LESS, COVERED BY TCT NO. 190603, AND REGISTERED IN THE NAME OF YK REALTY AND DEVELOPMENT CORPORATION, FOR AWARDED TO ACTUAL AND BONA FIDE TENANTS AT THE LOWEST POSSIBLE PRICE IN BARANGAY 158, ZONE 14, TONDO II, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM, BY APPROPRIATING THE AMOUNT OF FIVE MILLION PESOS (PhP. 5,000,000.00), NEEDED THEREFOR AND FOR OTHER PURPOSES" was amended by virtue of City Ordinance No. 8333, enacted on January 14, 2014 and approved on January 23, 2014 increasing its appropriation to Twenty Million Pesos (PhP. 20,000,000.00), or so much thereof, as may be necessary. The same section is hereby further amended and shall now read as follows:


**"SEC. 2. The amount of TWO HUNDRED SIXTY-FOUR MILLION SEVEN HUNDRED SEVENTY SIX THOUSAND PESOS (PhP. 264,776,000.00), or so much thereof, as may be necessary, to include all taxes and other incidental expenses, is hereby appropriated out of any available funds in the City Treasury, for the purpose of acquiring the property under the LAND-FOR-THE-LANDLESS PROGRAM of the City of Manila"**

**SEC. 2. Source of Fund.** – The appropriation for the implementation of this Ordinance shall be sourced from the provision of Ordinance No. 8804 or Supplemental Budget No. 1, FY 2022, enacted by the City Council of Manila and approved by the Mayor on January 17, 2022.


**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 9, 2022.
