AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 5 FOR THE REQUIREMENTS OF THE VARIOUS IMPROVEMENT PROJECTS OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF ONE HUNDRED FORTY-ONE MILLION THIRTY THOUSAND NINE HUNDRED NINETY-SEVEN PESOS (PHP. 141,030,997.00) AND FOR OTHER PURPOSES

EXPLANATORY NOTE

Every local government unit shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, the health and safety of its constituents, enhance the right of the people to a balanced ecology, enhance economic prosperity and social justice, and preserve the comfort and convenience of its inhabitants (Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code of 1991).

Local government units shall likewise exercise such powers and discharge such functions and responsibilities for the efficient and effective provisions of basic services and facilities which includes, among others, services and facilities related to general hygiene and sanitation, slaughterhouses, health services which includes health centers/hospitals and other infrastructure facilities to service the needs of the residents (Section 17 of R.A. No. 7160).

A supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160).

The City Treasurer and the City Accountant has issued the Certificate of Availability of Funds as supporting document to the promulgation of a Supplemental Budget.

The City Council likewise approved Resolution No. 10, Series of 2022 of the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2022 FOR THE VARIOUS IMPROVEMENT PROJECTS OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF ONE HUNDRED FORTY-ONE MILLION THIRTY-ONE THOUSAND PESOS (P141,031,000.00)".

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. - The FY 2022 Supplemental Budget of the City of Manila in the total amount of One Hundred Forty-One Million Thirty Thousand Nine Hundred Ninety-Seven Pesos (PhP. 141,030,997.00) is hereby appropriated to fund the following projects of the City of Manila, to wit:
