# **ORDINANCE NO. 8915**

AN ORDINANCE AUGMENTING VARIOUS ITEMS UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES THROUGH SAVINGS FROM THE FY 2022 ANNUAL BUDGET TO FUND PRIORITY PROGRAMS AND ACTIVITIES OF THE CITY OF MANILA AND FOR OTHER PURPOSES

### **EXPLANATORY NOTE**

The FY 2022 Annual Budget appropriated funds for various items under the Maintenance and Other Operating Expenses (MOOE) of the FY 2022 Annual Budget.

After due consideration, there is a need to augment various items from the FY 2022 Annual Budget through savings from other accounts of the FY 2022 Annual Budget to ensure the effective and efficient delivery of priority programs and activities of the City of Manila.

The City Treasurer and the City Accountant have issued the Certificate of Availability of Funds as supporting document to the said savings and augmentation.

Section 336 of Republic Act No. 7160, or the Local Government Code of 1991, provides that funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment an item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

The City Council approved Resolution No. 11, Series of 2022, of the Executive Committee of the City Development Council, entitled "A Resolution approving the amendment of the Annual Investment Program and Issuance of a Supplemental Investment Program for FY 2022 in relation to the Augmentation of Various Items under the Maintenance and Other Operating Expenses in the Total Amount of Two Hundred Sixty-Three Million Nine Hundred Fourteen Thousand Pesos (PhP. 263,914,000.00)".

Be it ordained by the City Council of Manila, in session assembled, THAT:
