**AN ORDINANCE ABOLISHING ONE (1) VACANT PLANTILLA POSITION OF NURSE IV IN THE JUSTICE JOSE ABAD SANTOS GENERAL HOSPITAL BY WAY OF SCRAP-AND-BUILD AND REPLACING THE SAME PLANTILLA POSITION WITH ONE (1) PHARMACIST III**


## **EXPLANATORY NOTE**

By virtue of this Ordinance, different plantilla items at Justice Jose Abad Santos General Hospital will be eliminated, and a new position will be created for them. According to Chapter III, Budgeting, Article I Local Government Budgets, Section 325 (d) of Republic Act No. 7160 or also known as the Local Government Code of 1991 which states: "In cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of this code and the civil service law, rules and regulations".

Also in the same act, the Title III, Human Resources and Development in Section 76 of Republic Act No. 7160 or also known as the Local Government Code of 1991 which stated: "Organizational Structure and Staffing Pattern. – Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission".

In times of pandemic, the "Dangal ng Bayan" and Officer in Charge, Hospital Director Merle D. Sacdalan – Faustino, along with the personnel of this hospital, continue to serve and protect for the people of the City of Manila in health, particularly at this time of epidemic.

In view of the foregoing, the approval of this Ordinance is earnestly sought.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. Declaration of Policy.** – It is hereby declared the policy of the City Government of Manila to faithfully observe the overriding goal of improving the delivery of vital services in terms of quality, scope, speed, accountability and affordability.

The city and its instrumentalities must promote focused use of limited resources on core functions and programs, while simultaneously cutting and scaling-down, phasing-out or abolishing non-core tasks.

**SEC. 2. Abolished Plantilla Position.** – One (1) Plantilla Position is hereby abolished under the Justice Jose Abad Santos General Hospital (JJASGH):

**SEC. 3. New Plantilla Position.** – New Plantilla Item is hereby created under the Justice Jose Abad Santos General Hospital:

**SEC. 4. Qualifications, Powers, Duties/Responsibilities.** – The qualifications, powers and duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC) and other relevant laws.


**SEC. 5. Appointments.** – The employment and appointment for those who will be occupying the herein subject position shall be within the prescribed qualification standards and guidelines set by the Civil Service Commission (CSC) and other relevant agencies.

**SEC. 6. Appropriation.** – The amount necessary for the creation of the one (1) new plantilla position shall be derived from the existing one (1) position to be abolished for this purpose and available Personal Services appropriations as provided for under the 2023 Executive Budget. Therefore, the herein subject position shall be funded through the succeeding Annual City Budget as part of the plantilla positions of personnel of the Justice Jose Abad Santos General Hospital.

**SEC. 7. Effectivity.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 22, 2022.
