ORDINANCE NO. 8917

AN ORDINANCE ABOLISHING ELEVEN (11) VARIOUS VACANT PLANTILLA POSITIONS IN THE UNIVERSIDAD DE MANILA BY WAY OF SCRAP-AND-BUILD AND REPLACING THE SAME PLANTILLA POSITIONS WITH THREE (3) POSITIONS, CONSISTING OF ONE (1) PROFESSOR I AND TWO (2) SUPERVISING ADMINISTRATIVE OFFICERS

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to faithfully observe the overriding goal of improving the delivery of vital services in terms of quality, scope, speed, accountability and affordability.

The city and its instrumentalities must promote focused use of limited resources on core functions and programs, while simultaneously cutting and scaling-down, phasing out or abolishing non-core tasks.

SEC. 2. Abolished Plantilla Positions. – The following eleven (11) positions are hereby abolished under the Universidad de Manila (UdM):

SEC. 4. Qualifications, Powers, Duties/Responsibilities. – The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Commission (CSC) and other relevant laws.


SEC. 5. Appointments. – The employment and appointment for those who will be occupying the herein subject positions shall be within the prescribed qualification standards and guidelines set by the Civil Service Commission (CSC) and other relevant agencies.

SEC. 6. Appropriation. – The amount necessary for the creation of the three (3) new plantilla positions shall be derived from the existing eleven (11) positions to be abolished for this purpose and available Personal Services appropriations as provided for under the 2023 Executive Budget. Therefore, the herein subject positions shall be funded through the succeeding Annual City Budget as part of the plantilla positions of personnel of the Universidad de Manila.

SEC. 7. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 22, 2022.
