AN ORDINANCE AUGMENTING THE WELFARE GOODS EXPENSES UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES THROUGH SAVINGS FROM THE ANNUAL EXECUTIVE BUDGET FY 2022 TO FUND PRIORITY PROGRAMS AND ACTIVITIES OF THE CITY OF MANILA AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Augmentation. - The hereunder item of appropriation in the total amount of Ten Million Four Hundred Fifty Thousand Pesos (P 10,450,000.00) shall be augmented through savings from the Annual Executive Budget FY 2022, to wit:
