ORDINANCE NO. 8921

AN ORDINANCE AMENDING SECTIONS 2 AND 3 OF ORDINANCE NO. 8482, ENTITLED: "AN ORDINANCE GRANTING BURIAL ASSISTANCE TO THE SURVIVING HEIRS OF SENIOR CITIZENS WHO HAVE DIED AND APPROPRIATING FUNDS FOR THE PURPOSE" AND ADDING THERETO THE REQUIREMENTS TO BE PRESENTED BY THE CLAIMANTS AND APPROPRIATING TWELVE MILLION PESOS (PHP. 12,000,000.00)

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2 of Ordinance No. 8482, is hereby amended and shall now read as follows:

“SEC. 2. Burial Financial Assistance. – The surviving heirs of any senior citizen who has died shall be granted burial financial assistance in the amount of **Two Thousand Pesos (PhP. 2,000.00)**, subject to the presentation of the following required original documents to the Office of the Senior Citizens Affairs:

- a. **Death Certificate of the deceased Senior Citizen with the official registry number of the Civil Registry Office – Manila;**
- b. **Funeral services contract and receipt indicating the name of the claimant;**
- c. **Issued Manila City Office of the Senior Citizen Affairs ID;**
and
- d. **Any valid government issued primary ID.**

Claimants shall be granted the Burial Financial Assistance PROVIDED that they submit the abovementioned requirements for the assistance within thirty (30) days upon the death of the Senior Citizen. PROVIDED FURTHER, that said deceased senior citizen was a beneficiary of the Manila City Senior Citizen Allowance and was not tagged as an inactive beneficiary before his or her death. PROVIDED FINALLY, that the only claimant of the burial financial assistance is the person named in the original funeral services contract and receipt, regardless of relations.”

SEC. 2. Section 3 of Ordinance No. 8482, is hereby amended and shall now read as follows:


“SEC. 3. Appropriation. – The amount of **Twelve Million Pesos (PhP. 12,000,000.00)**, or so much thereof as may be necessary, is hereby appropriated out of the funds in the City Treasury not otherwise appropriated, for the purpose of such financial assistance, for inclusion the next year budget or from the Special Activities Fund, Office of the Mayor for CY 2023.”

SEC. 3. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect on January 1, 2023 and should be published in two (2) newspapers of local circulation.

This Ordinance was finally enacted by the City Council of Manila on November 24, 2022.


